- The cooperation with the bookkeeper and the accountant is progressing well to get tax filings done and filed.

• Llewellyn van der Merwe asked why we're not using OpenCollective to raise money. Luca provided insights on how it has been used so far. Robert responded that there will be further analysis on the service to increase its usage.

Reports from Directors

- Philip Walton provided some updates from the Outreach Department, which is now active and growing. The Social Media Team is still looking for volunteers. New volunteers needed also to work on the joomla.org galaxy of websites.
- Harald Leithner informed the members that the Joomla Mastodon instance is up and running, but not yet announced, in response to a question from Christane Maier-Stadtherr. Accounts can be created at social.joomla.org.
- Benjamin Trenkle reported that the Maintainer Team is doing bi-weekly meetings to finalize
 and merge pull requests, in response to the question from members in the agenda. Nicola
 Galgano, Richard Fath and Harald Leithner contributed to the discussion about introducing a
 way to automatically mark stale Pull Requests and Issues that are inactive for months.
 Benjamin pointed out that a Production decision was to not auto-close stale issues and pull
 requests.

- Crystal Dionysopoulos offered to create some Playbooks on Mattermost to train people on topics like leadership, conflict resolution, management, inclusive communication, etc.. A poll has been run during the call on Google Meet.
- Laura Gordon remembered to regularly visit the events portal to see the nearest events about Joomla and announce events there.
